TERMS OF AGREEMENT OF APPLE HEATING DISCOUNT CLUB

Apple Heating Discount Club Memberships are subject to the following terms and conditions:

- 1. TUNE-UPS WILL BE SCHEDULED AT MUTUALLY AGREEABLE TIMES.** Discount Club memberships are a great value to the customer. One way we hold down the dues is to schedule your tune-up during otherwise slow times. Performing tune-ups on your equipment annually is equally effective, regardless of what month the tune-up takes place.
- 2. CANCELLATION.** This agreement may be cancelled by the customer at any time and all unused portion of dues will be refunded in full. Total cost of agreement divided by number of maintenance tune-ups determines unused portion of dues. Example: 1 2-year agreement with a total of 4 tune-ups would be 50% used after 2 tune-ups.
- 3. TERMINATION.** This agreement may be terminated by Apple Heating, at our option, if anyone other than an Apple Heating technician disturbs or works on items covered by this agreement. We also will have no duty or obligation to perform under this agreement if you have any past due accounts with us.
- 4. GUARANTEE OF EQUIPMENT AVAILABILITY.** Apple Heating makes no guarantee that equipment maintained by this agreement will not break down, or that it will be available to perform comfort conditioning. We will make every effort to provide prompt service under this agreement, but we are not responsible for delays.
- 5. AUTOMATIC RENEWAL.** This agreement will be automatically renewed at end of period when agreement expires for like term.
- 6. TRANSFERABLE.** This agreement is transferable at no cost to new owner should property be sold.
- 7. APPLE BUCKS.** Apple Bucks is a customer loyalty reward program. Customers who maintain membership in our Discount Club earn Apple Bucks that can be redeemed for discounts on the installation of new equipment as listed in the Apple Bucks schedule. Apple Bucks have no cash value and are not transferable. All accumulated Apple Bucks are lost if agreement is not renewed. Apple Bucks may only be used for equipment installations listed. Apple Bucks may not be used for any other products or services provided by Apple Heating.
- 8. GRACE PERIOD.** Apple Heating will allow a grace period of 30 days from date of expiration of agreement for customer to renew with no loss of coverage or accumulated Apple Bucks. Customers whose agreements are more than 30 days expired may purchase a new agreement but will not recover lost Apple Bucks.
- 9. REPAIR WARRANTY.** Repairs are warranted to the original purchaser of the agreement for 3 years, 6 years or lifetime - depending on agreement level at time of repair. Lifetime means the life of the existing equipment. Normal maintenance and wear items such as filters and belts are not covered by warranty. Refrigerant leak repairs are not covered. Other repairs may be excluded if customer declines recommended repairs.
